



Greetings from the Georgia Club Lamb Association!

As the 2024 show season is gearing up, we have again made a few changes to our Sanction Point Shows.

1. Sanction Show Fee \$150.00
2. Sanction Show is defined as One (1) Set of Showmanship Classes and One(1) Set of Weight Classes.
3. **NEW 2024:** Shows sanctioned for a particular weekend will be the ONLY GCLA sanctioned show for that region for that weekend (See map for details). In the event that two shows request the same weekend in the same region, preference will go to the show that requests the date first by emailing georgioclublambassociation@gmail.com UNLESS shows are on alternating weekend days (Example: one show is Friday, and one is Saturday OR Saturday/Sunday. In this case, two shows can be sanctioned on the same weekend in the same region.

Following is a list of criteria for a show to be considered a GCLA Sanctioned Point Show:

1. **NEW 2024:** GCLA sanctioned shows must be open to any Georgia exhibitor. Eligible exhibitors, for GCLA purposes, are those from Kindergarten(K) through Twelfth (12) Grade, however each show can use their own discretion as to what grades they allow.
2. GCLA must have show details including entry guidelines/rules, entry deadline, name of Judge (if available), and entry form to be posted to list of Eligible Sanction Shows on website. Please email all show information as soon as it becomes available.
3. All showmanship classes must be separated by grade with NO combined grades.
4. Classes must be Market in nature - Breeding Ewe classes are not eligible for points.
5. Be willing to provide show results to GCLA Secretary within two (2) weeks after conclusion of the show.
6. Be willing to allow GCLA to display banners and other educational information if available.
7. Fill out and return the Sanction Agreement along with the \$150 sanction fee.
8. Reminder – Shows with separated GA Born & Bred Division allow our youth exhibitors to acquire extra points for those that are entered in our Point System for Year End Scholarships.

The overall goal of the Georgia Club Lamb Association is to raise awareness of Georgia bred lambs by promoting shows and educational opportunities for the youth in our program. The points system is in place to encourage more exhibitors and help raise the number of entries for our point eligible Sanctioned Shows.
